If you decide to recycle waste selectively, we offer the following services:

- The most cost-effective option for our partners is to use their own vehicles to drop the collected recyclable waste at our site at Pécs, Eperfás út 3., which is open on working days between 6 am and 2 pm.
- If our partners don't have the necessary transport vehicles at their disposal or if they commission us to collect the waste, our company collects smaller quantities of waste (e.g., for schools, offices, shops, small businesses, etc.) by operating **selective collection rounds**. Our partners phone to let us know that a collection is required and our colleagues remove the collected secondary raw material within 2 working days.

The reusable waste prepared for transport (e.g.: boxed, bagged, baled, etc.) is



collected by BIOMARK 2000 Ltd staff from a central collection point at an easily accessible location by a **tent platform truck**. It is our partner's task to deliver the selectively collected waste from their site to the collection point.

If required, we are able to provide **sacks and boxes** for the storage of recyclable waste free of charge.

If quantities of packaging waste are produced (for example at large stores or industrial companies, etc.),

- we are able to provide **selective collection containers**.

The **emptying of the containers** may take place at a pre-agreed date and time arranged in advance in the case of regular orders, or, in the case of individual orders, within 0-48 hours of notification, depending on capacity.
